<p>Full application for erection of 16 dwellings and associated internal access roads, parking and landscaped areas, following demolition of existing buildings</p> <p>Wells Masonry Group Ltd, Ilsom Farm, Cirencester Road</p> <p><b>Decision: TTC does not support this application due to the lack of infrastructure, more traffic on our roads, impact on the surgery and schools, traffic problems will occur at the London Road/Cirencester Road junction. Under the planning statement 5.14, if this application is permitted TTC would prefer the affordable unit to be on-site. TTC would also like to request a contribution of £15,000 to assist with traffic improvements</b></p> <p>All Councillors voted against this planning application</p>	<p>Listed Building Consent for reinstatement and replacement windows, new ground floor slab, re-plastering, structural support of staircase and new external lighting</p> <p>Outbuilding land adj to 12 New Church Street</p> <p><b>Decision: It is unfortunate that the work has already been carried out without planning permission, but TTC note that these works have been carried out sympathetically.</b></p> <p>Councillors voted 5 in favour, 2 against, 1 abstentions</p>
