## 4. Joint working with Tetbury Town Council

### a. Update on architect

The new plans have now gone to planning application. On advice from the planners, the toilets and kitchen have been moved further forward. There has been no joint meeting with TTC. Our architect has been asked to prepare new costings for the building work

### b. Work on site – outside platform

Work is going well. Some bricks are missing and will need replacing at a cost of approx £300. Lots of passers by have stopped to admire the work and to give advice! One tree will need to be removed. It is proposed that plywood boxes are made and concreted in and the posts slotted into them and maybe a rope fixed along the length.

## 5. Funding and business planning

a. Treasurer's report. In the bank we have £31,297. This is due to eight calendar payments of £250 each and a donation of £1000. Two car boot sales raised £697 and Art in the Park and the evening concert by the Malmesbury Singers raised £538 and contributions in memory of Sue Stoner £690.

b. Report from Funding Group/progress of current bids. No progress to report with the bids this month. Barrie reminded us of the promise of £30,000 from Garfield Weston and he has also made contact with a local charity. Stephen Hirst explained about The Leader Fund which is now live. TTC will submit an interest this week re developing The Goods Shed as an arts centre. It is also putting in a bid for developing The Dolphins Hall as a community hub.

- c. Update of amending governing document CRM:0380177 submitted 24.03.15. Barrie Doyle proposed and Brecon seconded that the trustees accept the amendment which added to the original the following words – to operate an Arts Centre in the refurbished Railway Goods Shed in Tetbury for charitable, educational, recreational and community development purposes. Unanimous vote in favour and this therefore is amended under section 198 of the Charities Act 2011

  - e. **Heritage weekend and Boot Sale 12/13 September.** Swindon and Cricklade Society want to come and have a stand. The Boot Sale will need to be outside and we will borrow a gazebo to serve refreshments.
